APPROVING MAP OF RESUBDIVISION OF MORSE HEIGHTS

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS S. W. WONG, Registered Civil Engineer, entitled "RESUBDIVISION OF MORSE HEIGHTS Being a subdivision of Lots 1, 2 and 3, Morse Heights, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6018, filed in the office of the County Recorder of San Diego County, January 12, 1968.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Timely Terrace for public purposes, and said street is hereby declared a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Cielo Drive, adjacent and contiguous to Lots 1, 2, 3, 4 and 5, all as shown on this map within this subdivision and subject to the conditions set forth thereon.


