RESOLUTION DECLARING A PORTION OF 69th STREET
WITHIN THE CITY LIMITS OF SAN DIEGO TO BE A COUNTY HIGHWAY

ON MOTION of Supervisor Conde, seconded by Supervisor
Brown, the Board of Supervisors of the County of San Diego,
by not less than a four-fifths vote hereby adopts the following resolution:

WHEREAS, the County of San Diego contemplates the improvement of a
street known as 69th Street, from Waite Drive to Livingston Street, a dis-
tance of 0.18 mile, all in accordance with plans to be prepared by the
County Department of Transportation of the County of San Diego; and

WHEREAS, all of said street is within the city limits of the City of
San Diego; and

WHEREAS, in the opinion of this Board the construction of said street
lying within the city limits of the City of San Diego is of general County
interest and will be of general benefit to the County of San Diego; and

WHEREAS, under the provisions of the Streets and Highways Code of
the State of California, Section 1700 to 1704, both inclusive, by at least
a four-fifths vote of the members declare any highway lying in whole or in
part within a city to be a County highway, and upon the taking effect of a
city resolution containing the consent of the city thereto, said highway
becomes a County highway with respect to acquisition of right-of-way, con-
struction, maintenance, improvement and repair; NOW THEREFORE

IT IS RESOLVED, ORDERED AND DECLARED that the construction and im-
provement of 69th Street from Waite Drive to Livingston Street, a distance
of 0.18 mile, lying within the city limits of the City of San Diego is of
general interest to the County of San Diego.


IT IS FURTHER RESOLVED, ORDERED AND DECLARED that the previously described street lying within the city limits of the City of San Diego is to be a County highway.
