BE IT RESOLVED, by the Council of The City of San Diego as follows:

R 76 - 1745

1. That the offer of Haaker Equipment Company is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of THREE (3) VACTOR JET-RODDER MACHINES for a cost of \$74,642.51 each, terms less \$500.00 each, net 15 days, plus sales tax for a total of \$78,621.06 each; a total for three (3) machines of \$235,863.18.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$235,863.18 from the Sewer Revenue Fund 506, Program Element 69.97 Unallocated Reserve to Program Element 64.20, and then transfer said amount to Central Garage and Machine Shop Working Capital Fund 522 in the amount of \$235,863.18 for the expenditure from the Equipment Division Program Element 88.50 for the above purpose.
