That the bids of 1. Dorado Equipment Co. and 2. Hawthorne Machinery Co. are hereby accepted and the City Manager is hereby authorized to execute contracts for purchases as follows:

1. Dorado Equipment Co. for Section I - ONE (1) LOADER W/BACKHOE (Case Model 580B) at a cost of \$14,981.00; terms net 30 days, plus sales tax, less trade in allowance of \$2,000.00 for one (1) loader w/backhoe and Section III - ONE (1) TRACTOR LOADER (Case Model W-14) at a cost of \$25,502.00; terms net 30 days, plus sales tax, less trade-in allowance of \$3,200.00 for one (1) tractor loader, for a total cost of \$37,711.98 for Sections I and III.

2. Hawthorne Machinery Co. for Section II - ONE TRACTOR LOADER (Caterpillar Model 910) at a cost of \$29,563.00; terms 2% 30 days, plus sales tax, less trade-in allowance of \$4,000.00 for one (1) tractor loader for a total cost of \$26,710.04 for Section II.
