APPROVING MAP OF GLIDDEN COURT SUBDIVISION


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, Licensed Land Surveyor, entitled "GLIDDEN COURT SUBDIVISION Being a subdivision of Lot 22, in Block 63 of Linda Vista Unit No. 5, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 3208, filed in the office of County Recorder of San Diego County, April 1, 1955.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Glidden Court, for public purposes; and said street is hereby declared to be a public street and dedicated to public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated.
