


RESOLUTION NO. 215455 MAR 10 1976

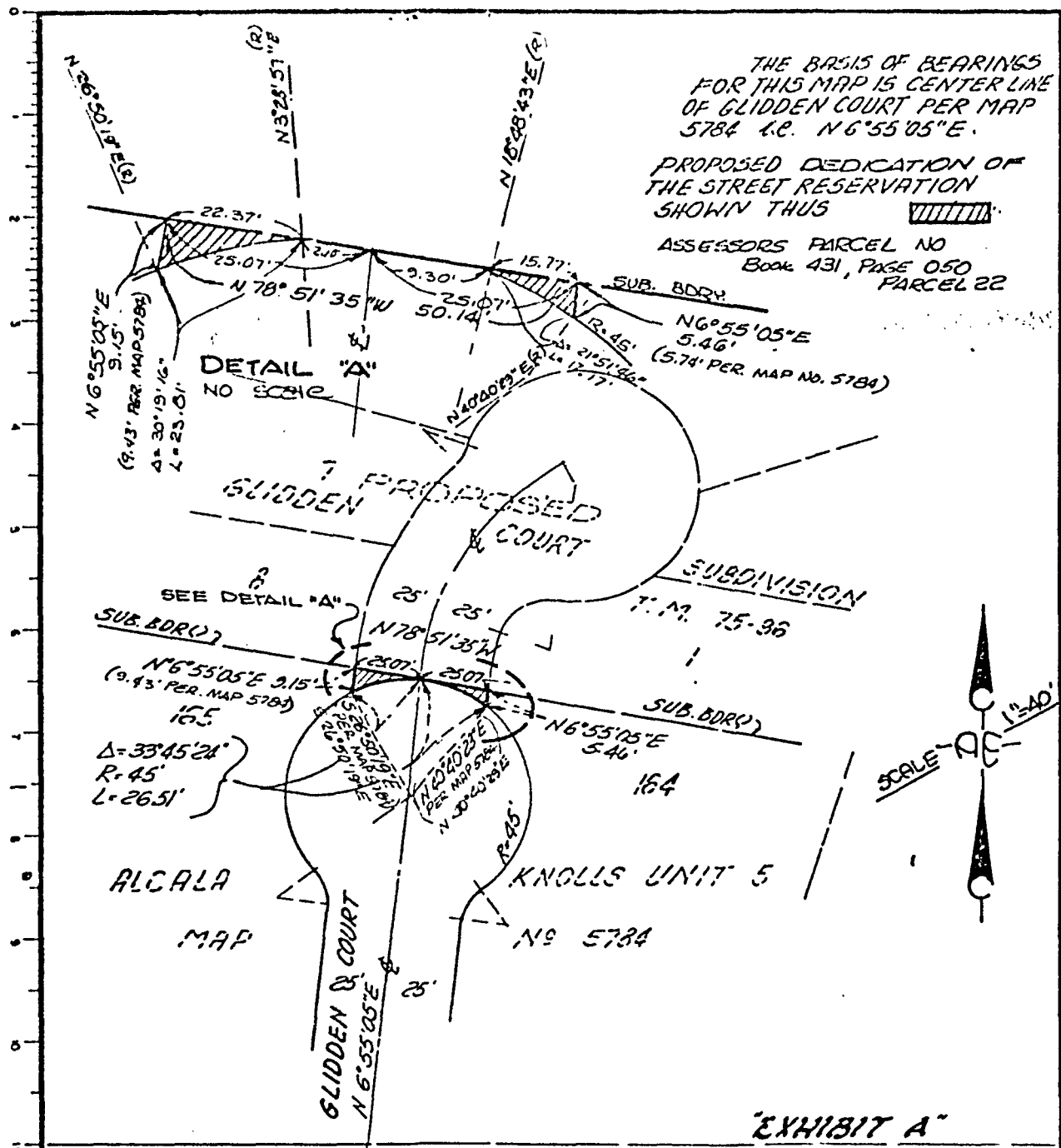
