


RESOLUTION No. 215463Adopted on MAR 10 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of CANADA DRY BOTTLING CO., of San Diego, executed in favor of The City of San Diego, bearing date of January 30, 1976, conveying to said city the permanent easement and right of way for an earth excavation or embankment, slope or slopes and incidents thereto, over, under, upon, along and across a portion of Lot 298 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the County Recorder of San Diego County on November 14, 1921 and is known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
