


RESOLUTION No. 215464Adopted on MAR 10 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MISSION VALLEY DEVELOPMENT, INC., a California corporation, executed in favor of The City of San Diego, bearing date of July 31, 1975, conveying to said city a permanent easement for the purposes of limiting and preserving in its natural state and as open space a portion of Lot 1, Mission Valley Inn, according to Map thereof No. 3347, on file in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
