RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO, CALIFORNIA, ORDERING  
CHANGES IN THE REPORT.

Park District No. 16 (Hendrix Park)

WHEREAS, in proceedings under the San Diego Park District Procedural Ordinance of 1969 and, in particular, Division 8 (commencing with Section 61.0801) of Article 1, Chapter VI of the San Diego Municipal Code the Council adopted resolution of intention, Resolution No. 215196, ordering the Superintendent of Streets to prepare the Report required by said ordinance and, pursuant thereto, the Superintendent of Streets has prepared the Report, including the four parts submitted with and made a part of the Report, the parts consisting of plans and specifications describing the proposed acquisitions and improvements, a diagram showing the assessment district and a proposed assessment of the costs and expenses of the proposed acquisitions and improvements, the Report being on file with the City Clerk; and




