

RESOLUTION NO. 215511

WHEREAS, on March 8, 1976, the Public Facilities and Recreation Committee considered R-76-1732, a proposed five-year Agreement with Consolidated Facility Services, Inc., to provide services as specified for the Convention and Performing Arts Center; and

WHEREAS, at the Public Facilities and Recreation Committee meeting, testimony was offered by Triple L Enterprises, Inc., stating that they were prepared to offer comparable services at a lesser cost to the City; and

WHEREAS, because both firms had submitted proposals subject to negotiation rather than sealed bids, several Committee members felt that there was a reasonable doubt as to exactly what was being offered by whom and reservations were also expressed as to whether a five-year Agreement would be in the best interest of the City; and

WHEREAS, the Committee resolved to recommend that Council direct the Manager to readvertise for sealed proposals for a one-year contract with a one-year extension at the City's option; and

WHEREAS, the Agreement proposed by the Manager on January 23, 1976 is to be used for contract specifications; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That all proposals received for providing maintenance and operations assistance for the Convention and Performing Arts Center for five (5) years are hereby rejected.

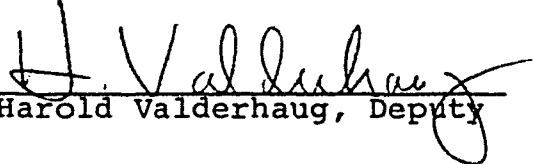
