Development Co., a partnership, for CONSTRUCTION OF MEMORIAL PARK - SENIOR CITIZENS' CENTER in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753546.
2. That the expenditure of \$70,000.00 is hereby authorized from Senior Citizens Building Project Fund (Fund No. 2550) and that the expenditure of \$11,248.00 is hereby authorized from General Fund (Fund No. 100) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF MEMORIAL PARK - SENIOR CITIZENS' CENTER in the City of San Diego, and related costs.
