2. That the expenditure of \$52,252.00 is hereby authorized out of the Park and Recreation Bond Fund (Fund No. 725), and that the expenditure of \$8,748.00 is hereby authorized out of the Sewer Revenue Fund (Fund No. 506) of the City of San Diego solely and exclusively for the purpose of providing funds for COMFORT STATION FOR PACIFIC BEACH DRIVE INCLUDING BASE BID AND ADDITIVE ALTERNATE in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$10,648.00 from CIP NO. 23-020.2 (6) to Park and Recreation Bond Fund Reserve, CIP NO. 90-725.
