Nachant, Inc., a corporation, for CONSTRUCTION OF MOUNT HOPE CEMETERY - EQUIPMENT GARAGE ADDITION in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753951.
2. That the expenditure of \$38,500.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF MOUNT HOPE CEMETERY - EQUIPMENT GARAGE ADDITION in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$13,700.00 from CIP No. 38-019(6) to Capital Outlay Reserve, CIP No. 90-245.
