BE IT RESOLVED, by the Council of The City of San Diego as follows: R76-1861

1. That the bid of \$35,196.00 by Sapper Construction Co., a corporation, for CONSTRUCTION OF CONCRETE BARRIER ON THE EASTBOUND RAMP OF WEST MISSION BAY DRIVE TO NORTHBOUND INGRAHAM STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753949.
2. That the expenditure of \$14,000.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) and that the expenditure of \$35,000.00 is hereby authorized from Gas Tax Funds (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF CONCRETE BARRIER ON THE EASTBOUND RAMP OF WEST MISSION BAY DRIVE TO NORTHBOUND INGRAHAM STREET in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$21,000.00 from CIP No. 54-549(6) to Capital Outlay Reserve, CIP No. 90-245.
