

RESOLUTION No. 215523

Adopted on MAR 17 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows: *R76-1858*

That the bids of 1. Badger Meter, Inc. 2. Hersey Products, Inc. 3. Rockwell International Corporation 4. Neptune Water Meter Company, A Subs. of Neptune International Corp. and 5. Gamon-Calmet Industries, Inc. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of WATER METERS AND PARTS for a period of one (1) year beginning March 1, 1976 through February 28, 1977 per prices on file in the Purchasing Department as follows:

1. Badger Meter, Inc. for Schedule III, Items 3 and 4, for commercial service meters, and parts for Badger meters at list price; terms net 30 days, plus sales tax with option to renew contract for an additional one (1) year; and

2. Hersey Products, Inc. for Schedule II, Items 2, 3, and 4, for turbine meters, Schedule IV, Items 1, 2 and 3 for general service meters, and for parts for Hersey meters at list price; terms net 30 days, plus sales tax, with option to renew contract for an additional one (1) year; and

3. Rockwell International Corporation for Schedule II, Item 1 and 5, for turbine meters, Schedule III, Items 1 and 2, for commercial service meters, and for parts for Rockwell meters at list price less 40%; terms net 30 days, plus sales tax, with option to renew contract for an additional one (1) year; and

4. Neptune Water Meter Company, A Subs. of Neptune International Corp., for parts for Neptune Meters at list price less 10%; terms net 30 days, plus sales tax and freight; and

5. Gamon-Calmet Industries, Inc. for parts for Gamon meters at list price less 40%; terms net 30 days, plus sales tax and freight.
