

RESOLUTION NO. 215530

MAR 17 1976

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by city council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of the ALLEY in Block 441, Clairemont Mesa Unit No. 4, Map No. 4146 has been relocated through the approval and dedication on this date of a portion of the alley, as more particularly shown on Drawing No. 13670-B, on file in the office of the City Clerk as Document No. 754702; and

WHEREAS, those properties adjoining that portion of the ALLEY to be vacated will continue to have access or will be accessible by the alternate route dedicated on this date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the ALLEY in Block 441, Clairemont Mesa Unit No. 4, Map No. 4146, as more particularly shown on Drawing No. 13668-B, on file in the office of the City Clerk as Document No. 754703, which said drawing is attached hereto, and made a part hereof, be and the same is hereby vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
