BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LEONA CHAMBERS, who acquired title as Leona Winger, a married woman, executed in favor of The City of San Diego, bearing date of January 23, 1976, conveying to said City a portion of Lots 15 and 16 in Block 3 of Crittenden's Addition, according to Map thereof No. 303, filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SIXTH AVENUE.
