

RESOLUTION NO. 215541

MAR 17 1976

WHEREAS, the City Council, in executive session, agreed to expend a sum not to exceed \$10,000 for the City's participation in the Outer Continental Shelf litigation; and

WHEREAS, the Council of Local Governments, of which the City has been a participant, has recommended the retention of the Center for Law in the Public Interest to conduct the litigation; and

WHEREAS, the City now desires to withdraw from the litigation to avoid incurring further expenditures; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CENTER FOR LAW IN THE PUBLIC INTEREST, a California corporation, to compensate Center for City's allocated share of expenses incurred in litigation of oil and gas drilling on the Outer Continental Shelf, and further to dismiss the City of San Diego from the litigation and terminate our contractual obligations, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754911.


