

RESOLUTION NO. 215558

MAR 23 1976

WHEREAS, in 1926 the Board of State Harbor Commissioners entered into two leases of Mission Bay tidelands at the north end of Sail (Crescent) Bay at the termination of which the lessees are required to peaceably surrender and vacate the leased areas for the subsequent use by the public and to reconstruct and restore the leased areas to public beach condition by removal of structures by the lessees; and

WHEREAS, the leases were for a period of 50 years and will expire on May, 1976; and

WHEREAS, The City of San Diego is the successor in interest to the State of California as lessor; and

WHEREAS, in order to accurately establish the lease boundaries, the location of structures thereon, and to serve as a base map for possible future public improvements in this area, an accurate survey and plot is required; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to advertise for a professional consultant to make an aerial survey of

2. That said City Manager be and he is hereby directed to notify the above-referenced lessees that their leases will expire in May, 1976.
