

RESOLUTION No. 215572Adopted on MAR 24 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the delivery of that instrument entitled Offer to Dedicate, executed by STREET PROPERTIES, INC., a California corporation, in favor of The City of San Diego, bearing date of October 2, 1974, offering to dedicate to public use for street purposes a portion of Section 29, Township 18 South, Range 1 West, San Bernardino Meridian, as more particularly described in said instrument, be and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance of delivery, the City does not dedicate to public use for street purposes the portion of land described in said instrument but reserves the right to accept said offer to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to transmit said offer to dedicate and a certified copy of this resolution to the Property Director for further handling.
