BE IT FURTHER RESOLVED, that the expenditure of \$10,000 and \$3,000 is hereby authorized out of Gas Tax Fund 220 and Gas Tax Fund 220 Reserve, respectively, solely and exclusively for the purpose of providing funds for the above-referenced services and related expenses.
