
Adopted on MAR 24 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an easement agreement with the San Diego & Arizona Eastern Railway Company for the widening of Coronado Avenue across the railway company's property, under the terms and conditions set forth in the form of easement agreement on file in the office of the City Clerk as Document No. 754774.

BE IT FURTHER RESOLVED, that the expenditure of \$10,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for reimbursing the railway company for timber planking and related costs incurred in the above-referenced project.
