BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the PILIPINO-AMERICAN SENIOR CITIZENS OF SAN DIEGO COUNTY CORPORATION for the purpose of reimbursing rent and other operational expenses incurred by the project known as Operation Samahan Senior Center at 401 Market Street for the period between February 1, 1976 and June 30, 1976, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754782.

BE IT FURTHER RESOLVED, that City Revenue Sharing funds in an amount not to exceed \$1,750 from Fund 100, Department 05.61, be used for this purpose so long as the activities of the project conducted at 401 Market Street are in keeping with federal Revenue Sharing purposes and guidelines.
