A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING THE CONSOLIDATION OF A SPECIAL MUNICIPAL BOND ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON JUNE 8, 1976, WITH THE STATEWIDE PRIMARY ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, this Council has commenced proceedings and intends to call a special municipal bond election in the City to be held on June 8, 1976 for the purpose of submitting to the qualified voters of the City a general obligation proposition as set forth in this resolution; and

WHEREAS, it is desirable that this special municipal bond election be consolidated with the statewide primary election to be held on the same date and that within the City, the election precincts, polling places, voting booths and election officials for the two elections be the same, and that the Board of Supervisors of the County of San Diego be authorized to canvass the returns of the special municipal bond election, and that this special municipal bond election and the statewide primary election be held in all respects as if there were only one election; and

WHEREAS, this Council within the time required by law has or will adopt an ordinance calling for a special municipal bond election and consolidating it with the statewide primary election;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Board of Supervisors of the County of San Diego is hereby requested to consolidate a special municipal bond election to be held in the City of San Diego on June 8, 1976 with the statewide primary election to be held on the same date.

2. The exact form of the proposition to be voted upon at the special municipal bond election as such proposition shall appear on the ballot is as follows:

<p>PROPOSITION _____. CITY OF SAN DIEGO BOND PROPOSAL FOR THE PURCHASE OF CERTAIN COMMUNITY CONCOURSE PROPERTIES:</p> <p>To achieve savings in overall financing costs and to increase funds available for capital projects, shall the City incur a bonded indebtedness in the principal amount of Eleven Million Five Hundred Thousand Dollars to accomplish the immediate purchase from bond funds of certain Community Concourse properties which constitute a City Plan?</p> <p>This Proposition requires a two-thirds vote.</p>	YES

The proposition shall be designated on the ballot by a letter printed on the left margin of the square containing the description of the measure as provided in Section 10219 of the Elections Code of the State of California.

3. That the Board of Supervisors of the County of San Diego is hereby authorized to canvass the returns of this special municipal bond election and is requested to conduct the elections in all respects as if there were only one election using only one form of ballot.

4. That the Board of Supervisors of the County of San Diego is requested to issue to all officers of the County charged with duties pertaining to the statewide primary election appropriate instructions to take any and all steps necessary for the holding of a consolidated election.
