


RESOLUTION No. 215607Adopted on MAR 25 1976

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Memorandum of Understanding with the SAN DIEGO REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM, the originals of said Memorandum of Understanding and First Amendment thereto are on file in the office of the City Clerk as Document Nos. 749912 and 753088, respectively, for the purpose of increasing by \$2,500 the amount of Comprehensive Employment and Training Act of 1973 Title II funding for the Public Service Employment Program for the balance of fiscal year 1976, pursuant to the terms and conditions set forth in the form of Second Amendment to Memorandum of Understanding on file in the office of the City Clerk as Document No. 754793.
