APPROVING MAP OF SERBIAN PLACE UNIT NO. 2 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled SERBIAN PLACE UNIT NO. 2 Being a subdivision of Lots 1 through 11 and 22 through 28 and portions of Lots 12 through 14 inclusive and Lots 18 through 21 inclusive of Block 83, together with portions of Galveston Street (formerly 6th Avenue), Gesner Street (formerly G Street) and of the alley in said Block 83 adjacent to the aforementioned lots of Morena all as closed and vacated to public use in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 809, filed in the office of the County Recorder of San Diego County, January 2, 1896.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Bay Canyon Court and a portion of Clairemont Drive and a portion of Gesner Street for public purposes; and said street and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, all abutters' rights of access in and to Clairemont Drive, adjacent and contiguous to Lots 17, 23 and 24, all as shown on this map within this subdivision and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in the Owner's certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities; and those easements listed in the Owner's certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
