Duane M. Wolfe	Transportation	\$400	Mr. Wolfe is a Drafting Aide in the Communications and Electrical Division. He suggested that "as-built" drawings of traffic signal and street light circuitry be micro-filmed and hard copies be used by field personnel. This suggestion has resulted in a time savings of field personnel of \$7730 per year. This is a partial award pending final 12-month review of this procedure.
Manuel C. Guaderrama	Police	\$350	Mr. Guaderrama is a Captain in the Police Department. He suggested that the San Diego County Jail process the City's drinking drivers that qualify for quick release, so as to eliminate duplication of efforts. This saves an estimated \$12,449 per year in Officers' time. A partial award is being made pending final 12-month review of this procedure.
