1. That the bid of \$268,000.00 by Hydro-Mechanical Co., a corporation, for MODIFICATIONS TO THE MIRAMAR WATER FILTRATION PLANT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753869.
2. That the expenditure of \$340,720.00 is hereby authorized from Water Revenue Fund (Fund No. 502) of the City of San Diego solely and exclusively for the purpose of providing funds for MODIFICATIONS TO THE MIRAMAR WATER FILTRATION PLANT in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$62,280.00 from CIP 72-028.1 to Water Revenue Fund (Fund No. 502) Unallocated Reserve.
