RESOLUTION NO.

WHEREAS, in January, 1974, the City received a refund of \$89,327.03 from California Western States Insurance Company, which sum represented a refund resulting from favorable life insurance claims experience during the preceding three-year contract; and

WHEREAS, because a strong possibility existed that the life insurance carrier would apply a significant rate increase at that time, the sum refunded was deposited in a Deposit Trust Fund to minimize the potential impact on both employees and the City of the anticipated increase; and

WHEREAS, said anticipated increases failed to materialize when the City subsequently awarded new contracts; and

WHEREAS, the life insurance contract was recently renewed for one year with no increase, and it is now recommended that the refund should be distributed to the employees and the City from which source said funds originated; and

WHEREAS, several refund methods were considered and evaluated to achieve the most equitable method of refunding said funds in a manner designed to achieve the objective to which said funds were originally earmarked; and

WHEREAS, the employee organizations of the City were consulted in this situation, and it is agreed that the most equitable method would be to use the refund to pay premiums for supplemental and additional life insurance coverage for employees since the refunded sum was of such origin; and

WHEREAS, it is estimated that this course of action would provide payments of premiums for seven pay periods based on current experience; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby fully authorized to expend the sum of \$89,327.03 from the Deposit Trust Fund 3021, and further, make appropriate adjustments to the departments of The City of San Diego in a sum not to exceed \$3,000, solely and exclusively for the purpose of making premium payments to California Western States Insurance Company on behalf of covered City employees for seven pay periods.
