

RESOLUTION NO. 215654

MAR 31 1976

WHEREAS, at its February 2, 1976, meeting the Public Facilities and Recreation Committee Recommended that all landscape architecture organizations be put on the mailing list of the Design Consultant Selection Committee and that all such organizations be requested to designate a candidate representative to the Selection Committee (one Landscape Representative to be chosen); and

WHEREAS, at said meeting the Public Facilities and Recreation Committee also recommended that the Design Consultant Selection Committee shall issue progress reports on prime design consultant contracts awarded, including subcontracts resulting therefrom; that said reports shall be disseminated to the Council and all interested parties within 30 days of the awarding of prime contracts and shall include: the identification of projects by complete title used in the original advertisement, the date and medium of original advertisement, the name of the prime contractor and dollar amount of the contract, and the name of subcontractors and the dollar amount of subcontracts; and

WHEREAS, it was also recommended at said meeting by the Public Facilities and Recreation Committee that in addition to progress reports, a yearly report shall be issued by the

Selection Committee every June which shall recapitulate all the information contained in the progress reports for the preceding fiscal year; and

WHEREAS, at its March 1, 1976 meeting, the Public Facilities and Recreation Committee further clarified its February 2, 1976, recommendations by recommending that the above-mentioned progress reports include the identification of all design consultants, both prime and subcontracts, who will contract to provide services for projects together with a description of their responsibilities as indicated in Form 255 and including the specification of dollar amounts of both prime and subcontracts or the percentage basis upon which payment will be based; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby directed to communicate with all landscape architectural organizations regarding the proceedings of the Design Consultant Selection Committee to ensure that all such landscape architecture organizations be put on the mailing list of said Committee and that all such organizations be requested to designate a candidate representative to the Selection Committee (one Landscape Representative to be chosen).

2. That the Design Consultant Selection Committee is hereby directed to issue progress reports and yearly reports which set forth recipients and value of prime and subdesign consultant contracts in a manner consistent with the requirements provided for above.
