BE IT RESOLVED, by the Council of The City of San Diego as follows:

*77C-1974*

1. That the bid of \$677,000.00 by M. Arrieta & Son, Inc., a corporation, for PACIFIC HIGHWAY PIPELINE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753762.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$321,000.00 within Water Revenue Fund (Fund No. 502) from the Unallocated Reserve (P.E. 69.79, Obj. Acct. 3495) to CIP City Force and contract (P.E. 66.92, Obj. Acct. 3275).
3. That the expenditure of \$854,000.00 is hereby authorized from Water Revenue Fund (Fund No. 502) of the City of San Diego solely and exclusively for the purpose of providing funds for PACIFIC HIGHWAY PIPELINE in the City of San Diego, and related costs.







## CERTIFICATION OF UNENCUMBERED BALANCE


