BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of \$742.00 is hereby authorized from Park Service District Fund 11430, solely and exclusively, for the purchase of 40 eight-inch anodized aluminum building letters for the Kearny Mesa Community Park and Recreation Center.
