BE IT RESOLVED, by the Council of The City of San Diego as follows:

That this Council hereby requests the State Legislature to initiate legislation to add Section 6375.1 to the Revenue and Taxation Code of the State of California as set forth in Exhibit A attached hereto and made a part hereof. The purpose of this addition is to exempt The City of San Diego and other governmental agencies from the imposition of state sale or use tax when the transfer of goods from the storerooms of one governmental agency to another takes place.

There are exempted from taxes imposed by this part the gross receipts from the sale of goods or the transfer of goods from the storerooms of one governmental agency to another.
