

RESOLUTION No. 215704Adopted on APR 7 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JOSEPH M. BURKHART, a married man as to an undivided one-half interest, JON L. JENTZ, a single man as to an undivided one-half interest, as tenants in common, and ELEANOR M. BURKHART, wife of Joseph M. Burkhardt, executed in favor of The City of San Diego, bearing date of January 21, 1976, conveying to said City a portion of Lot 117 of Skyline Hills Unit No. 1, according to Map thereof No. 4052, filed in the Office of the County Recorder of San Diego County, January 8, 1959, as more particularly described in said deed, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$124,000 from Environmental Growth Fund 2505, \$1,875 from Park Ordinance Fund 11691 and \$11,000 from Capital Outlay Reserve Fund 245 for acquisition costs of the above described property is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
