BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City's delegate to the Comprehensive Planning Organization ("CPO") be and is hereby instructed to vote in support of the "Updated Regional Transportation Plan"

(Agenda Report No. R-48) dated January 26, 1976, a copy of which is on file in the office of the City Clerk as Document No. 755196, as amended by the Transportation and

Land Use Committee as evidenced by a report from that Committee dated March 30, 1976, a copy of which is on file in the office of the City Clerk as Document No. 755197,

plus the additional amendment by adding on page 114 of the Plan the following language: "debt financing methods shall be approved by the electorate." However, in the event the CPO does not accept all the above amendments, the City's delegate is to vote for the Plan.
