That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with STONE & YOUNGBERG, MUNICIPAL FINANCING CONSULTANTS, INC., for the purpose of consultant services for the development of implementation procedures and the financing of major improvements in the NORTH CITY WEST COMMUNITY, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754893.

BE IT FURTHER RESOLVED, that the offer of the NORTH CITY WEST PROPERTY OWNERS ASSOCIATION to reimburse said City for an additional \$2,500, bringing the total reimbursement to The City of San Diego for the above-referenced consultant services to \$7,500, be, and the same is hereby accepted.

BE IT FURTHER RESOLVED, that the expenditure of \$7,500 is hereby authorized from Trust Fund 3021, solely and exclusively, for the payment of said consultant services.
