1. That the bid of \$57,840.00 by Daley Corporation, a corporation for the IMPROVEMENT OF THE ROSE CANYON BIKE PATH, PHASE I in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 754009.
2. That the expenditure of \$26,000.00 is hereby authorized out of the Capital Outlay Fund 245 and that the expenditure of \$72,600.00 is hereby authorized out of Gas Tax Fund 220 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF THE ROSE CANYON BIKE PATH, PHASE I in the City of San Diego, and related costs.




