


RESOLUTION No. 215728Adopted on APR 14 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Agreement with CURTIS JONES and BEULAH M. JONES, husband and wife, for the purpose of providing City with street and slope easements, and Jones with a portion of City-owned property with driveway and walkway improvements in lieu of severance damages, for the proposed widening of Market Street between 47th Street and Euclid Avenue, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754992.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$2,400 from Fund 244 is hereby authorized solely and exclusively for the purposes stated in the above agreement.
