

RESOLUTION No. 215729Adopted on APR 14 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of CURTIS and BEULAH M. JONES, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of February 10, 1975, conveying to said City the permanent easement and right of way for a public street and an earth excavation or embankment, slope or slopes and incidents thereto, affecting a portion of Lot 432 of Sunshine Gardens, according to Map thereof No. 1804 filed in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby set aside and dedicated as and for a public street and the same is hereby named MARKET STREET.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$2,000 from Fund 244 is hereby authorized solely and exclusively to provide for the above stated acquisition of easements.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
