WHEREAS, The City of San Diego and Curtis Jones and Beulah M. Jones, husband and wife, have entered into an agreement in connection with the widening of Market Street between 47th Street and Euclid Avenue; and

WHEREAS, it is appropriate that the City should now convey to Curtis Jones and Beulah M. Jones, husband and wife, a portion of Lot 431 of Sunshine Gardens, according to Map thereof No. 1804, filed in the Office of the County Recorder of San Diego County, in accordance with said agreement; and

WHEREAS, the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended that the aforesaid transfer be made; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No. 754994, granting to CURTIS JONES and BEULAH M. JONES, husband and wife, a portion of Lot 431 of Sunshine Gardens, according to Map thereof No. 1804, as more particularly described in said form of grant deed, which property has been determined to have a value of \$500.
