WHEREAS, on March 24, 1976, the City Council adopted Resolution No. 215606 for the purpose of increasing Comprehensive Employment and Training Act of 1973 Title VI funds by \$118,200 for the San Diego Community College District; and

WHEREAS, said resolution was in error and must be hereby amended to properly designate said funds into Title VI and Title II categories; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fourth Amendment to Memorandum of Understanding with the SAN DIEGO COMMUNITY COLLEGE DISTRICT, the originals of said Memorandum of Understanding and First, Second and Third Amendments thereto are on file in the office of the City Clerk as Document Nos. 749831, 750008, 752347 and 752997, respectively, for the purpose of increasing by \$100,000 the amount of Comprehensive Employment and Training Act of 1973 Title VI funding and for the purpose increasing by \$18,200 the amount of Comprehensive Employment and Training Act of 1973 Title II funding for the Public Service Employment Program for the balance of fiscal year 1976, pursuant to the terms and


