RESOLUTION NO. 215739

WHEREAS, on March 24, 1976, the City Council adopted Resolution No. 215608 for the purpose of increasing Comprehensive Employment and Training Act of 1973 Title VI funds by \$224,200 for the San Diego Unified School District; and

WHEREAS, said resolution was in error and must be hereby amended to properly designate said funds for Title II purposes and not for Title VI purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fifth Amendment to Memorandum of Understanding with the SAN DIEGO UNIFIED SCHOOL DISTRICT, the originals of said Memorandum of Understanding and First, Second, Third and Fourth Amendments thereto are on file in the office of the City Clerk as Document Nos. 749832, 750009, 750139, 752046 and 752998, respectively, for the purpose of increasing by \$224,200 the amount of Comprehensive Employment and Training Act of 1973 Title II funding for the Public Service Employment Program for the balance of fiscal year 1976, pursuant to the terms and conditions set forth in the form of Fifth Amendment


