

RESOLUTION No. 215741Adopted on APR 14 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$31,219 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for conversion of the former business office at Central Police Headquarters to a Police Emergency Communications Center for the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project pursuant to the recommendation of the City Manager and the submission of his estimates indicating said work can be done more economically by City Forces than if let by contract.
