

RESOLUTION NO. 215742 APR 14 1976

WHEREAS, The City of San Diego has entered into a \$100,000 grant agreement (Grant No. 07-25-01663) with the United States Department of Commerce, Economic Development Administration to provide staffing for Community Development Program efforts and for support for the Growth Management Study, as authorized by City Council Resolution No. 214508, adopted on November 6, 1975; and

WHEREAS, said grant agreement extends for the time period between July 1, 1975 to June 30, 1976, and it is now necessary and desirable to extend said grant termination date from June 30, 1976, to December 31, 1976, so as to better coordinate the grant activities with the existing Community Development Block Grant program activities; and

WHEREAS, Section 3(c) of the "General Terms and Conditions" of the grant agreement provides that any changes or amendments in the terms and conditions of the grant require the prior authorization of the United States Assistant Secretary of Commerce for Economic Development; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to apply, for and on behalf of said City, to the United States

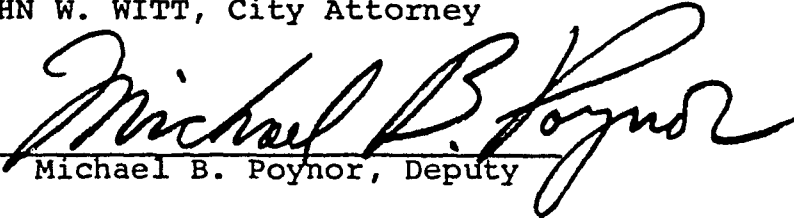
