

RESOLUTION NO. 215760

WHEREAS, in June, 1973, the Council of The City of San Diego adopted Resolution No. 208285, declaring its intent to initiate annexation proceedings regarding certain unincorporated County "islands"; and

WHEREAS, the City Manager, after meeting with property owners, determined and reported to Council in May of 1974, that little or no support for annexation had been generated among property owners; and

WHEREAS, in August, 1975, the County Board of Supervisors notified residents in the unincorporated areas that the County would discontinue its contract with the California Division of Forestry for fire protection in these areas; and

WHEREAS, the County Board of Supervisors extended the contract with the Division of Forestry to provide protection to the unincorporated areas until June 30, 1976; and

WHEREAS, residents in the unincorporated "islands" within the City of San Diego sphere of influence will be without fire protection after June 30, 1976; and

WHEREAS, the City of San Diego Fire Department can furnish fire protection to these unincorporated islands without contracting additional facilities; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego requests the County Board of Supervisors to act as the lead agency in proceedings to annex to the City of San Diego the

6. Pomerado Road & **I**-15 (uninhabited).
7. Miramar Reservoir Area (uninhabited).

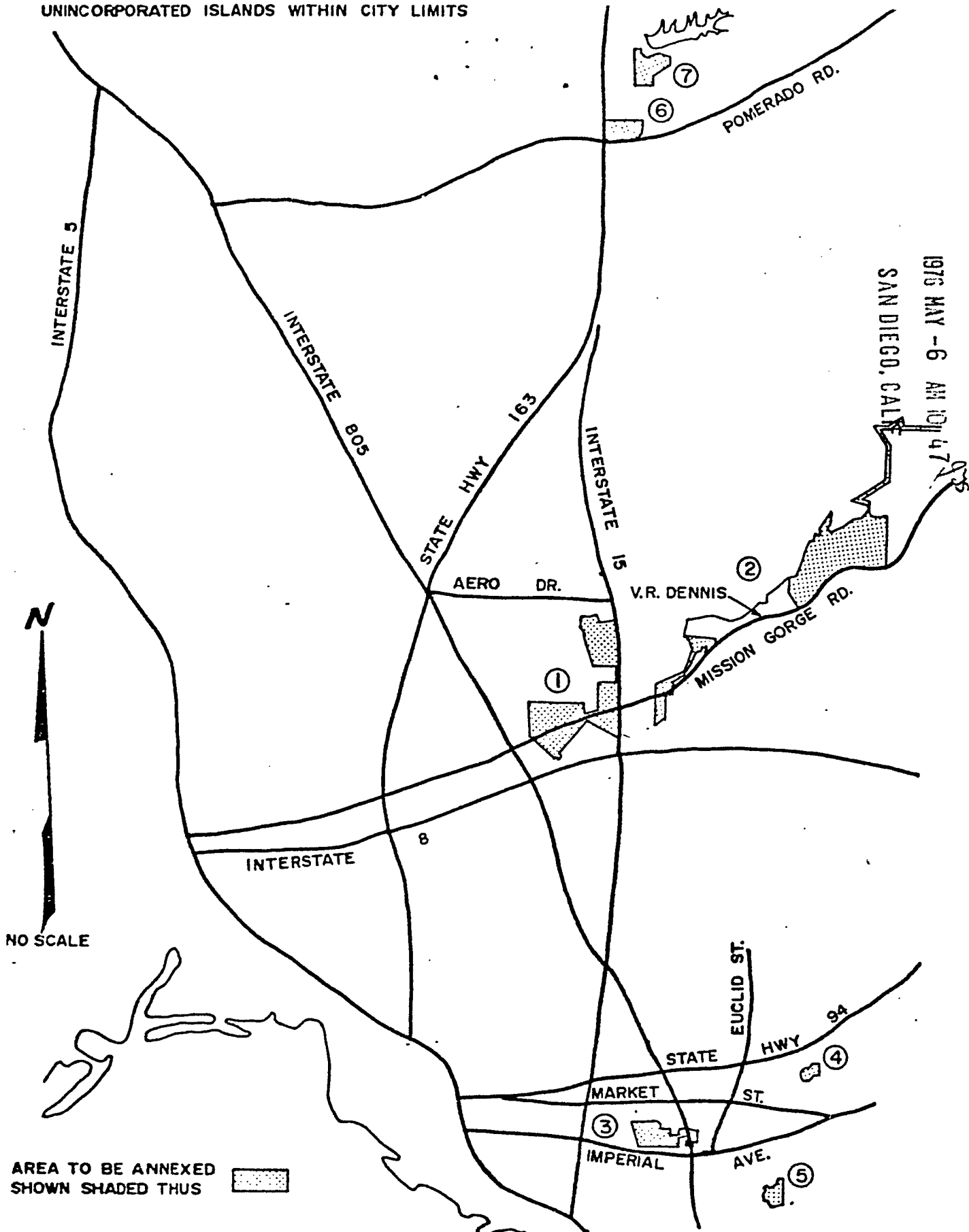
