RESOLUTION OF THE COUNCIL OF THE CITY

BIDS ON IMPROVEMENT BONDS.

WHEREAS, the Council adopted Resolution No. 215510 ordering the giving of a notice inviting bids for the purchase of all the improvement bonds described therein and the notice has been duly published; and



BE IT RESOLVED, by the Council of The City of San Diego, that the bids for the purchase of the improvement bonds for Park District 16 (Hendrix Park) are hereby rejected and the purchasing agent is hereby directed to return the bids, unopened, to their respective bidders, together with the checks accompanying the bids.
