BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE SKIRBALL INVESTMENT COMPANY, a general partnership, executed in favor of The City of San Diego, bearing date of January 22, 1976, conveying to said City a portion of the Northerly Half of the West Half of Lot 62 of the Ex-Mission Lands of San Diego, commonly known as Horton's Purchase, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named LOGAN AVENUE.

That the expenditure of not to exceed \$11,275 from Gas Tax Fund 220 to cover acquisition costs of the above property is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
