BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, for modification of traffic signals, safety lighting and roadway geometrics on BALBOA AVENUE and MORAGA AVENUE, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755048.

BE IT FURTHER RESOLVED, that the expenditure of \$53,698 and \$16,302 is hereby authorized out of Capital Outlay Fund 245 and Gas Tax Fund 220, respectively, of The City of San Diego, solely and exclusively as City's estimated construction costs in the above-referenced project.
