

RESOLUTION No. 215787Adopted on APR 21 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$5,815 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for the purchase of materials and related costs associated with the construction and realignment of the Miramar Sanitary Landfill access road, in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above-referenced project, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract, at a cost not to exceed \$1,315.
