That the expenditure of \$678,380 is hereby authorized out of the Gas Tax Fund, Fund 220; that the expenditure of \$36,000 is hereby authorized out of the Capital Outlay Fund, Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF MIRAMAR ROAD - OLD MIRAMAR ROAD TO CARROLL ROAD, BASE BID INCLUDING ADDITIVE ALTERNATE 1, ADDITIVE ALTERNATE'S A, B, AND C in the City of San Diego, and related costs.
